THE FOURTH MONTHLY REPORT FROM THE MINISTRY OF HEALTH TO THE MINISTER ON THE IMPLEMENTATION OF THE RECOMMENDATIONS OF THE GISBORNE CERVICAL SCREENING INQUIRY REPORT

BACKGROUND INFORMATION

1. In response to recommendation 46 of the Inquiry Report, the Director General will supply monthly reports to the Minister. This is the fourth of these monthly reports.

COMMENT

Evaluation of the National Cervical Screening Programme

- 2. The National Screening Unit has received the Draft Report on the Evaluation of the Follow-up and Treatment of Women with Abnormal Screening Histories (Part 2 of the National Evaluation) from the University of Otago. The NSU is currently reviewing the findings of the report as part of its Quality Monitoring work programme. (Recommendations 1 & 3).
- 3. Planning work on the Cancer Audit (Part 3 of the National Evaluation) is proceeding under the current legislative framework and will proceed to the ethical approval process. The requirement to obtain regional ethics committee approval could delay the start of the audit component itself. Members of the Cancer Audit Project Team recently returned from a visit with the Leicester Cancer Audit team. (Recommendations 1 & 3)
- 4. The first Independent Monitoring Group's National Cervical Screening Programme quarterly monitoring report was publicly released 30 July 2001. The monitoring report covers the three months from October 2000 to December 2000, and provides for the first time regular information on how specific programme providers are performing against a range of national indicators. (Recommendation 4)

Changes to Legislation

- 5. A total of 101 public submissions were received in response to the discussion document outlining proposed changes to Section 74A of the Health Act to enable the effective monitoring, audit and evaluation of the NCSP. The submissions have been analysed and a cabinet paper is now being drafted. (Recommendations 14,15, 17)
- 6. Two cabinet papers covering the Health & Disability Commissioner Amendment Bill, and the Health Professionals Competency Assurance Bill – Complaints & Discipline, have been submitted for approval by the Education and Health Cabinet Committee. (Recommendations 34, 35, 36, 44)

Ethics Committees

7. An extension to the period for consultation (was due end 31 July 2001) on the Draft Operational Standards for Health and Disability Ethics Committees has been granted to enable completion of a joint submission from Ethics Committees. (Recommendations 18, 20)

Key Milestones Update

- 8. The Third Briefing Report identified key milestones for reporting in this fourth Report.
 - Recommendations 4: Release of NCSP IMG Quarterly Monitoring Report.

The Report was released publicly on 30 July.

• **Recommendations 7:** Completion of external peer review of NCSP Statistical Report

Peer review of the NCSP Statistical Report 1996 to 1998 is ongoing. There has been some delay in receiving feedback from reviewers.

• **Recommendations 14, 16, 17:** Completion of analysis of public submissions in response to Section 74A Discussion Document

Analysis of the 101 public submissions has been completed.

• **Recommendations 34, 35, 36, 44:** Preparation of Cabinet Paper regarding Health Professionals Competency Assurance Bill – Complaints and Discipline Provisions and Health & Disability Commissioner Act changes.

Papers have been prepared for the Minister of Health for coalition consultation and Education and Health Cabinet Committee approval.

• **Recommendation 39:** Letter sent to Medical Practitioners reminding them that cervical smear tests are not a means of diagnosing cervical cancer and that they should be alert to the symptoms of cervical cancer.

The National Screening Unit will meet with the Royal College of General Practitioners to discuss the most effective means of informing GPs regarding this issue.

Upcoming Milestones

- **Recommendation 1:** Completion of comprehensive written protocol for the carrying out of the Cancer Audit. Ethics Committee approval for the Cancer Audit.
- **Recommendations 14, 16, 17:** Cabinet Paper submitted.

• **Recommendation 28, 40, 41, 42:** Workforce Development Project Second Draft Report completed
